He is also a skilled neutral who serves on the court-sponsored mediation and early neutral evaluation panels of the Northern and Eastern Districts of California.

Josh is a past president of the San Francisco Bay Area Intellectual Property American Inn of Court, the premier organization in Northern California dedicated to fostering skills, professionalism, collegiality, and ethics among the intellectual property bench and bar. He is a member of the American Intellectual Property Law Association and the ABA Section of Intellectual Property Law; he co-chairs both organizations' subcommittees on patent litigation policy, and is a member of their committees on patent, trademark, and copyright litigation and legislation. He writes and speaks regularly on intellectual property issues for legal and industry audiences. Between college and law school, Josh worked as a computer and networking consultant and graphic designer.

Josh is also an avid skier who currently serves as National Legal Advisor (outside general counsel) to the National Ski Patrol. In addition to various legal roles in the organization, he was an elected member of the Board of Directors from 2016 to 2019, and national treasurer from 2017 to 2019.
